We're pleased to announce that the R.C.M.P. Firearms Support Services Branch has classified our LAR-15 .223/5.56 Magazines as "Pistol Magazines" having a legal capacity of 10 rounds.

This culminates a year long effort to establish a design concept that meets the legislative requirements and conforms to the Firearms Act. [Click here to read the ruling.](#)

The best part is that, because of the way our Canadian law is worded it's the magazine that determines the capacity, not what the magazine is eventually used in. The LAR-15 10 Round Magazine can have a 10 round capacity regardless of the firearm you use them in... If you own an AR pistol or an AR rifle then you now have access to 10 round legal magazines.

These are high quality, name brand magazines, with Magpul anti-tilt followers and complete markings to clearly identify them as 10 Round Pistol Magazines. RCMP has already notified CFC, CBSA and various law enforcement offices that this magazine may legally hold 10 rounds.

We will be offering two versions... a standard floorplate version and a Tactipul version with a Ranger style floorplate for \$5 more.

We expect to begin shipping these new 10 round magazines to a number of dealers across Canada by late April... so contact you local dealer to place your orders now... if your local dealer isn't carrying them then we'll be accepting orders starting May 1st.
